Please provide an overall state of play of your project: what are the achievements of the project at this stage? Are the initial project activities and objectives being carried out and reached so far?

The project were planned to arrange one trans-national meeting in each country during the project period (Coordinator with local parners will arrange two meeting). As part of these trans-national project meetings production of two intellectual outputs will be planned and discussed. In-between meetings the partners will work on collecting data and information related to intellectual outputs, which will be shared with the other partners and be a foundation for discussions and conclusions.

In each country, the local partners in the country together will prepare a program for the meeting lasting for two days. The program have two focuses:

- 1. To give a presentation of framework, activities, actors/institution and cooperation relevant in relation to the subjects focused in the project.
- 2. To share information, plan activities and discuss formation of models according to the objectives for two intellectual outputs.

Two transnational meetings which was planned in this first period is conducted according to plan. The programs were very relevant, extensive and well performed in both Norway and Slovenia. This wer fully according to expectation. Production of intellectual output were also focused as planned. Due to the great variation of responsibilities, experiences and background, it was experienced some difficulties in making a standard system for collection of data and background information: Description og Best/good Practises. This delayed the progress; however, the matter was discussed and clarified in the second meeting.

Generally, the progress of the project is in line with the plan, and the outcome have been good. Somehow the outcome is above expectations when it comes to how much the partners have been able to be presented to of good practices and various ways of working in the two countries so far visited. Information which is transferable and/or to inspiration for better approaches.

Please describe further in details the project activities supported by the grant for Project Management and Implementation that have been carried out until now.

As the program period started in December 2017 the planning started for the Kick-Off meeting, even if some preparations was done before. The meeting should be held in the area of the coordinator, in Hordaland, Norway. Date and timeframe for the meeting was fixed, accommodation was booked by the coordinator, partners identified their representatives to attend the meeting, and these booked their air tickets. Except 2 international participants all arrived the day before the Meeting and left the day after, or later. Totally 23 representatives from the partners attended the kick-off Meeting.

After approval of the project, unfortunately two partners in Wales found they could not afford to participate. During the week of regions and cities in Brussels 2018 a new relevant and interested partner was found: Instituto Professionale per líndustria e l'Atigiantato, Italy.

All partners attended according to the program application (adjusted for change of partners) as follows: EARLALL - European Association of Regional and Local Authorities for Lifelong Learning, - Agenzia Umbria Ricerche, Italy, - Instituto Professionale per líndustria e l'Atigiantato, Umbria, Italy, - BSC Kranj, Slovenia, - Solski School Centre, Kranj, Slovenia, - Barcelona Activa, Catalonia, Spain, - Sotra upper secondary school, Hordaland, Norway, Knarvik upper secondary school, Hordaland, Norway,

Municipality of Fjell, Hordaland, Norway, - Hordaland County Council, Norway (coordinator).

The purpose of the meeting was to present all partners for each other, establish contacts and relationships between all the partners and participants, create a better understanding of the objectives of the project, define a plan for the implementation of the project and the production of the intellectual outputs, agree on the finances, location of meetings, reporting procedures etc.

The program was developed in cooperation with all 4 partners in Hordaland. All the 4 partners contributed in the program, together with some invited local cooperating institutions. In the program all partners presented themselves for the others.

All international participants accommodated in the same hotel to make contact easy. Representatives for the local partners attended the first breakfast in the hotel, to establish the first social contact. The group had all meals together and were together, giving good opportunities to establish contact, share information and discuss topics. From the program: Welcome to Hordaland and to the Project Coordinator by Director of regional development. Visit to

Sotra upper secondary school with presentations on education and training programs, including representative for local industry. Visit to Municipality of Fjell, with presentation of urban planning and challenges including a guided street walk in Straume urban centre. Visit to Knarvik upper secondary school with presentation of the school and the teaching and training programs. Presentation by municipality of Lindås on development of Knarvik urban centre, - ambitions, planning and challenges. Visit to FRAMO; oil related industry which cooperates with Knarvik upper secondary school on training programs.

After each session, it was arranged a short summing-up meeting. The objective of these meetings was for partners to reflect on observations and methods presented.

A brief report presenting the program with pictures illustrating the program activities were made available for all partners on 8th February. Notes from all meetings were taken for future use in the project work.

The Kic-Off meeting was ended by a project meeting, where the partnership planned for the next trans-national meeting, and for the partners work on intellectual outputs.

It was agreed that next trans-national meeting should be in Slovenia in May 2018. All partners should ahead of the meeting identify and present at least one example of best practice related to sustainable development of urban centres, where planning authority, VET and local businesses were involved, all or some of these sectors (Intellectual Output 1). Guidelines for the collection and presentation should be worked out by AUR, evaluated by Barcelona Activa, and then distributed to all partners. The ambition was to discuss this material in the second meeting.

The meeting concluded on the timetable for the project, the distribution of duties and funding, and established a good relationship between the partners. Partners approved on the objectives of the project and committed themselves to fulfil their duties. Good relationships were established between the participants. The experience in communication in English varied, however all participants were active in the program.

How is the monitoring of the project being carried out so far and by whom?

The partners themselves share views and experiences in the project meetings, discuss activities and progress, and plan for the further activities.

The coordinator and the local national partners have shared ecperiences and views in the Meeting after second trans-national Meeting.

There are no formal body defined to monitor the project. The coordinator and and partners will montoring activites and reuslt based on the descrition ain the application, combined with experiences and lesson learnt by project activities and partners competance.

How did the project partners contribute to the project so far? Has the distribution of tasks been adjusted since the application stage?

All partners have contributed according to expectations. All have participated in the two trans-national meetings conducted so far. All have focused on the intellectual output 1, however, the discription of how to select and describe "Best Practice" was showed to be a bit unclear for partners. The matter was discussed in the second trans-national meeting, and an adjusted description was after this meeting forwarded to all partners. All will present relevant "Best Practices" before third trans-national meeting where the topic will be discussed with the objective to develop a first version of a model according to Intellectual output 1.

The local partners in Hordaland, Norway planned, arranged and implemented the first trans-national meeting in a positive way according to the program.

The local partners in Slovenia planned, arranged and implemented the second trans-national meeting in a positive way according to program.

All partners have attended the two trans-national meetings held so far, and have given the contributions required.

If your project involves other organisations, not formally participating in the project, please briefly describe their involvement.

The partnership is open to involve and cooperate with relevant organisations and/or institutions in the activities of the Project. Relevant is participation in parts of the program during trans-national meetings. This will be possible when it is agreed by the partnership, - and it is concidered to be to the benefit of achieving the objectives of the Project. Municipality of Lindås, Hordaland, where Knarvik upper secondary school is located has been involved. Nordhordland næringslag, - an umbrella organisation for the local industry in the same area has been involved too and attended the second trans-national meeting. These organisations have provided information and contributed to the discussions in the partnership.

After the second trans-national meeting in Slovenia, all participants who represent all the national partners in

Hordaland, Norway have met, discussed and summarised the information and experiences from Slovenia. Minutes have been made from these meeetings to be used in the continuation of the project.

The representatives of all partners have their full and busy jobs with high responsibilities. Participants in theis project are employees in the respective organisations, who are in the line of responsibilities, and have to fulfill their operational duties. Involvement in the Project is based on interest, and ambitions towards increased competance. This is a challenge when it comes to be able to get away from daily duties for trans-national Meetings. However, these difficulties have been overcome and all partners have till now attended all Meetings (2).

The relatively high number of partners also gives some challenges when it comes to getting all partners to respond and produce within set deadlines. The coordinator remind and push partners to deliver what is required within time. At the same time the coordinator apply some flexibility to be able to have the required results.
